

## **The DEADLINE for submissions is August 1st, 2008!**

- The WV FREE Emergency Contraception Campaign is open to residents of West Virginia who are between the ages of 15 and 25 years as of May 15, 2008.
- By participating in this contest, entrants and their parents or legal guardians agree to be bound by these Official Rules and by the decisions of the judges appointed by WV FREE.
  - Decisions of the judges are final and binding.
  - Incomplete entries will be ineligible for judging.
  - WV FREE will not acknowledge receipt of entries.
  - WV FREE reserves the right to verify the eligibility of the winning entries.
  - All entries become the property of WV FREE Emergency Contraception Campaign.
  - WV FREE reserves the right to alter any submitted design--whether winning or not--for use during or after the contest ends.
  - This Contest is subject to all applicable federal, state, and local laws.
  - The Contest begins on May 15, 2008, at 12:01 a.m. Eastern Time and ends on August 1, 2008 at 11:59 p.m. Eastern Time

1. **How to Enter: Send us a 7x10" print ad that sends a positive and/or informative message about emergency contraception to the following address: WV FREE, P.O. Box 11042, Charleston, WV 25339.** By entering, entrants agree to abide by the contest rules and certify their entry or entries to be their own work. You may enter as many times as you wish. Remember that:
  - Incomplete entries will be ineligible for judging;
  - WV FREE reserves the right to alter any entry for its own use during and after the contest ends;
  - All entries become the property of WV FREE;
  - WV FREE will not acknowledge receipt of entries; and
  - Entries must be received by August 1, 2008.
2. **Judging:** The judges will assess the entries for their creativity, originality, clarity, and suitability for use by WV FREE in the West Virginia Emergency Contraception Campaign. Judges' decisions on all matters are final.
3. **Prizes:** One Grand Prize winner will receive \$200, and his/her winning design will be featured in the statewide WV FREE newsletter and promotional materials and may be published by local newspapers and national and/or statewide sister organizations. Two (2) Second Prize winners will be chosen; each will receive \$50. Substitution, transfer, or cash equivalents will not be offered in exchange for the cash prizes. Registration and/or trademarks used in this Contest are the property of the respective trademark owners and are used herein for identification purposes only. Prizes will be awarded to the winner(s) by name. Any federal, state and/or local taxes and all other expenses associated with the

- prize and not explicitly defined herein are the sole responsibility of the winner. If the winner is a minor, then his/her parents/guardians will be fiscally responsible for taxes and other expenses associated with the prize.
